1. Agreement Scope:

This Agreement sets forth the terms and conditions under which Party A and Party B agree to enter into a legally binding contract. Both parties acknowledge full authority to enter this Agreement and agree to comply with all terms herein.

2. Obligations of the Parties:

Party A shall perform the obligations as outlined in this Agreement, including but not limited to timely delivery of goods or services and compliance with all applicable laws and regulations of Canada. Party B shall fulfill payment obligations and cooperate to facilitate the performance of this Agreement.

3. Payment Terms:

Payment shall be made by Party B to Party A as specified in the attached Schedule A. All payments are exclusive of applicable taxes unless otherwise stated. Payments shall be completed in Canadian Dollars via mutually agreed method.

4. Term and Termination:

This Agreement shall commence upon execution by both parties and continue until completion of obligations or termination by either party with written notice, subject to applicable provisions governing termination for cause or convenience.

5. Confidentiality:

Both parties agree to keep confidential all proprietary or sensitive information exchanged in connection with this Agreement and shall not disclose such information to any third party without prior written consent, except as required by law.

6. Liability and Indemnity:

Each party shall be liable for damages resulting from their own negligence or breach of this Agreement. Parties agree to indemnify and hold harmless the other party from any claims arising out of their respective actions.

7. Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of Canada. Any disputes arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts located within the appropriate province or territory of Canada.

8. Entire Agreement:

This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof and supersedes all prior agreements, understandings, or communications, whether written or oral.

9. Amendments:

Any amendments or modifications to this Agreement must be in writing and signed by authorized representatives of both parties to be effective.

10. Severability:

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

11. Notices:

All notices under this Agreement shall be in writing and delivered by hand, mail, courier, or email to the addresses provided by the parties.

12. Execution:

This Agreement may be executed in counterparts, each of which shall be deemed an original but all of which constitute one and the same instrument. Electronic signatures shall be deemed valid and binding.
