1. Custody and Parenting Time

The parties agree that the best interests of the child(ren) shall be the paramount consideration in determining custody and parenting arrangements. In the event of disagreement or dispute regarding custody or parenting time, the parties agree to attempt mediation or family dispute resolution before seeking court intervention.

6. Change of Residence

Neither parent shall relocate the child(ren) outside of [specify area or distance] without prior written consent from the other parent or a court order.

7. Access and Contact

Non-custodial parent shall have reasonable access to the child(ren), subject to any restrictions or conditions agreed herein or ordered by the court.

8. Health and Education

Both parents shall have access to child(ren)'s medical, dental, psychological, school, and extracurricular records, and shall be involved in important decisions.

9. Religious Upbringing

10. Travel

11. Documentation

The parties agree to keep the terms and existence of this Agreement confidential except as required by law or for enforcement purposes.

19. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Province of Alberta and the laws of Canada applicable therein.
