Section 1 – Purpose of Agreement

This Agreement sets out the terms and conditions under which the Service Provider will provide the agreed services to the Client in accordance with Canadian law.

Section 2 – Term and Termination

This Agreement shall commence upon execution and remain in effect until the completion of the services or until terminated by either party upon written notice, subject to any outstanding obligations.

Section 3 – Services

The Service Provider agrees to provide the services described above in a professional and timely manner consistent with industry standards.

Section 4 – Fees and Payment

The Client shall pay the Service Provider the fees as outlined above. Payments shall be made in Canadian Dollars unless otherwise mutually agreed. Late payments may incur interest as permitted by law.

Section 5 – Confidentiality

Both parties agree to maintain confidentiality of any proprietary or sensitive information exchanged during the term of this Agreement, except as required by law or consented to in writing.

Section 6 – Intellectual Property

All intellectual property created or delivered in connection with the services shall remain the property of the Service Provider unless otherwise assigned in writing.

Section 7 – Liability and Indemnity

The Service Provider shall perform services with reasonable skill and care but shall not be liable for indirect or consequential damages. The Client shall indemnify the Service Provider against claims arising from misuse or unauthorized actions.

Section 8 – Compliance with Law

Both parties agree to comply with all applicable laws, regulations, and codes of practice relevant to the performance of this Agreement within Canada.

Section 9 – Dispute Resolution

Any disputes arising out of or related to this Agreement shall be resolved through negotiation in good faith, and if unresolved, may be submitted to mediation or arbitration in accordance with Canadian arbitration laws.

Section 10 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.

Section 11 – Notices

Any notice required or permitted under this Agreement shall be in writing and deemed given when delivered personally, sent by registered mail, courier, or electronic mail to the addresses set forth above or such other address as may be designated.

Section 12 – Entire Agreement

This document constitutes the entire Agreement between the parties and supersedes all prior discussions, understandings, and agreements.

Section 13 – Amendments

No amendment to this Agreement shall be effective unless in writing and signed by both parties.

Section 14 – Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remainder shall continue in full force and effect.

Section 15 – Waiver

Failure to enforce any provision shall not constitute a waiver of future enforcement of that or any other provision.

Section 16 – Force Majeure

Neither party shall be liable for delays or failure to perform due to causes beyond reasonable control, including acts of God, government actions, or labor disputes.

Section 17 – Independent Contractor

The Service Provider is an independent contractor and nothing in this Agreement creates a partnership, agency, or employment relationship.

Section 18 – Assignment

Neither party may assign or transfer this Agreement without the prior written consent of the other party.

Section 19 – Counterparts and Electronic Signatures

This Agreement may be executed in counterparts and by electronic means, each of which shall be deemed an original.

Section 20 – Signatures

The parties have executed this Agreement as of the date first written above.
