1. Description of Services

Coach agrees to provide coaching services as described in this Agreement. Coaching is a collaborative process that facilitates self-directed learning, personal growth, and goal attainment. Coach does not provide professional advice, therapy, or counseling.

2. Client Responsibilities

Client agrees to be open, honest, and committed to the coaching process. Client acknowledges that coaching requires active participation and that results depend on Client's efforts and commitment.

3. Confidentiality

Coach agrees to keep all information shared by Client strictly confidential except as otherwise required by law. Confidentiality does not extend to information that Coach is legally obligated to disclose or that involves a risk of harm to Client or others.

4. Term and Termination

This Agreement commences on the Effective Date and remains in effect until terminated by either party. Either party may terminate this Agreement upon written notice. Termination does not relieve Client of obligations to pay fees for services rendered prior to termination.

5. Fees and Payment

Client agrees to pay the fees as specified. Payments are due according to the schedule outlined above. Late payments

may result in suspension or termination of services.

6. No Guarantees

Client acknowledges that Coach makes no guarantees or warranties regarding the results of coaching services. Client assumes full responsibility for decisions and actions taken during and after coaching.

7. Limitation of Liability

To the fullest extent permitted by law, Coach's liability for any claim arising out of or relating to this Agreement shall be limited to the total fees paid by Client under this Agreement. Coach shall not be liable for any indirect, incidental, or consequential damages.

8. Independent Contractor

Coach is an independent contractor and nothing in this Agreement shall be construed to create an employer-employee, partnership, or joint venture relationship.

9. Dispute Resolution

The parties agree to attempt to resolve disputes amicably through good faith negotiations. If resolution cannot be reached, disputes shall be resolved by binding arbitration in accordance with the laws of Canada.

10. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.

11. Entire Agreement

This Agreement constitutes the entire agreement between Coach and Client regarding coaching services and supersedes all prior agreements, understandings, and communications.

12. Amendments

Any amendments or modifications to this Agreement must be made in writing and signed by both parties.

13. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

14. Waiver

Failure by either party to enforce any provision of this Agreement shall not constitute a waiver of future enforcement of that or any other provision.

15. Assignment

Client may not assign or transfer any rights or obligations under this Agreement without prior written consent of Coach.

16. Notices

All notices required under this Agreement shall be in writing and delivered personally, by mail, or electronic means to the addresses provided herein.

17. Force Majeure

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, war, or governmental actions.

18. Client Acknowledgment

Client acknowledges having read and understood the terms of this Agreement and agrees to be bound thereby.

19. Signatures

This Agreement may be executed in counterparts and delivered electronically, each of which shall be deemed an original.

20. Coaching Ethics

Coach agrees to abide by the International Coach Federation Code of Ethics or equivalent applicable standards.
