Either party may cancel this Agreement by providing written notice to the other party. If Client cancels less than 14 days before the Event, deposit shall be forfeited. If DJ cancels, all payments received shall be refunded in full to Client. Neither party shall be liable for failure to perform due to causes beyond reasonable control such as acts of God,

government restrictions, or emergencies.

Performance Conduct and Compliance:

DJ agrees to perform in a professional manner and comply with all applicable laws, regulations, and venue policies. DJ shall not play music or content that violates copyright laws or contains unlawful or offensive material. Client shall ensure a safe environment free from harassment or discrimination.

Liability and Indemnification:

DJ shall not be liable for any damages, losses, or injuries occurring at the Event except to the extent caused by DJ's gross negligence or willful misconduct. Client agrees to indemnify and hold harmless DJ from any claims, damages, or expenses arising from Client's negligence or breach of this Agreement.

Intellectual Property:

DJ retains all rights to their original mixes, recordings, and materials. Client shall not record, distribute, or broadcast DJ's performance without prior written consent.

Force Majeure:

Neither party shall be held liable for failure to perform due to events beyond their reasonable control, including but not limited to natural disasters, acts of government, or other emergencies.

Entire Agreement:

This Agreement constitutes the entire understanding between the parties and supersedes all prior negotiations, understandings, and agreements. Any amendments or modifications must be in writing and signed by both parties.

Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of Canada and the province in which the Event takes place. The parties agree to submit to the exclusive jurisdiction of the courts of that province for any disputes arising under this Agreement.
