Purpose of Agreement:

This Agreement is intended to set forth the terms and conditions regarding the care, custody, control, and upbringing of the Child named herein. Both Parents/Guardians agree to cooperate fully and act in the best interests of the Child in accordance with applicable Canadian laws.

Custody and Access Arrangements:

1. Legal Custody: Both Parents/Guardians shall share joint legal custody of the Child, making major decisions affecting the Child's welfare jointly. 2. Physical Custody: The Child shall reside primarily with _____. The other Parent/Guardian shall have reasonable access as agreed upon or ordered by a court. 3. Access Schedule: The Parents/Guardians agree to the following access schedule:

Decision Making:

Both Parents/Guardians agree to confer and make decisions jointly regarding the Child's education, health care, religion, extracurricular activities, and other significant matters affecting the Child's welfare.

Child Support:

The Parents/Guardians acknowledge that child support obligations are governed by the Federal Child Support Guidelines and applicable provincial laws. Any child support payments shall be made in accordance with such laws or as otherwise mutually agreed in writing.

Health Care and Medical Decisions:

Both Parents/Guardians shall have access to the Child's medical records and shall jointly make all major health care decisions. In case of emergency, the Parent/Guardian with the Child shall make timely medical decisions and inform the other Parent/Guardian as soon as possible.

Education:

Both Parents/Guardians shall participate in decisions concerning the Child's education, including choice of school, extracurricular activities, and special educational needs.

Communication:

The Parents/Guardians agree to keep open and respectful communication with each other concerning all matters relating to the Child.

Dispute Resolution:

Any disputes arising under this Agreement shall be resolved amicably through mediation or other alternative dispute resolution methods before resorting to litigation.

Modification:

This Agreement may be amended or modified only by written agreement signed by both Parents/Guardians or by court order.

Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of Canada and the applicable province or territory.

Acknowledgment:

Both Parents/Guardians acknowledge that they have read and understood this Agreement, that they enter into it voluntarily, and that it is legally binding and enforceable.
