Agreement Terms:

The parties agree as follows:

Section 1 – Custody and Access

The parties agree to share custody of the child(ren) as follows. Custody shall be joint/shared, with parenting time and decision-making responsibilities divided in the best interests of the child(ren). Specific schedules, holidays, and special occasions shall be mutually agreed upon and documented in attached schedules.

Section 2 – Decision-Making Authority

Both parents shall share joint decision-making authority regarding the child(ren)'s health, education, religious upbringing, and welfare. In the event of disagreement, the parties agree to mediate or arbitrate in good faith before seeking court intervention.

Section 3 – Child Support

Parent 1 agrees to pay child support to Parent 2 in accordance with the Federal Child Support Guidelines as applicable in Canada. The amount, frequency, and method of payment shall be set out in the attached schedule and may be reviewed periodically.

Section 4 – Healthcare

Both parents shall ensure that the child(ren) receive necessary medical, dental, and psychological care. Each parent shall notify the other of any significant health issues, appointments, or emergencies promptly.

Section 5 – Education

The parents shall mutually decide upon the child(ren)'s educational arrangements, including choice of school, extracurricular activities, and special needs support.

Section 6 – Communication

The parents shall maintain open and respectful communication regarding the child(ren)'s welfare and schedules. The child(ren) shall have reasonable access to both parents at all times.

Section 7 – Relocation

Neither parent shall relocate the child(ren) more than 50 kilometers from the current residence without prior written consent from the other parent or a court order.

Section 8 – Dispute Resolution

In the event of disputes arising from this Agreement, the parties agree to attempt resolution through mediation or arbitration before commencing legal proceedings.

Section 9 – Changes to Agreement

This Agreement may be amended only by written agreement signed by both parties. Changes related to parenting time, custody, or support shall be consistent with the best interests of the child(ren) and applicable laws.

Section 10 – Legal Compliance

This Agreement is intended to be legally binding and enforceable under Canadian law. Both parties acknowledge having had the opportunity to seek independent legal advice prior to signing.

Section 11 – Confidentiality

The terms of this Agreement and any related negotiations shall remain confidential except as required by law or agreed by the parties.

Section 12 – Termination

This Agreement shall remain in effect until modified or terminated by mutual agreement or court order. Either party may seek modification upon a material change in circumstances impacting the child(ren)'s welfare.

Section 13 – Parenting Plan Schedules

The attached schedules form an integral part of this Agreement and outline detailed arrangements for parenting time, holidays, vacations, transportation, and communication.

Section 14 – Responsibilities of Each Parent

Each parent agrees to support the child(ren)'s relationship with the other parent, provide a safe and nurturing environment, and foster cooperation and respect.

Section 15 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the Province of _____, Canada. The parties consent to the exclusive jurisdiction of the courts in this province.

Section 16 – Signatures and Acknowledgements

The parties acknowledge that they have read, understood, and voluntarily accept the terms of this Parenting Agreement. They confirm full disclosure and no duress or coercion.
