1. Acknowledgement of Risks

2. Waiver and Release

In consideration of being permitted to participate in the activity, I hereby release, waive, discharge, and covenant not to sue the Organizers, their agents, employees, officers, directors, volunteers, and affiliates (collectively, the "Released Parties") from any and all liability, claims, demands, actions, or causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or my property, whether caused by the negligence of the Released Parties or otherwise.

3. Indemnification

I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all claims, demands, losses, liabilities, damages, costs, and expenses (including legal fees) arising out of my participation in the activity or any breach of this Release.

4. Medical Condition and Emergency Treatment

I represent that I am in good health and do not have any medical condition that would prevent my safe participation in the activity. I authorize the Released Parties to obtain medical treatment for me in the event of an emergency and agree to be responsible for any related costs.

5. Compliance with Laws and Rules

I agree to comply with all applicable laws, regulations, and rules applicable to the activity and to follow all instructions and guidelines provided by the Organizers.

6. Photography and Media Release

I consent to the use of my image, photograph, voice, or likeness in any media for promotional or educational purposes without compensation or further approval.

7. Legal Compliance and Governing Law

This Release shall be governed by and construed in accordance with the laws of Canada. Should any provision be found unenforceable, the remainder shall remain in full force and effect. I acknowledge that this Release is intended to be as broad and inclusive as permitted by Canadian law.

8. Severability

If any provision of this Release is determined to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

9. Understanding and Voluntary Execution

I have read this Release carefully, fully understand its terms, and sign it voluntarily without any inducement or assurance of any nature. I intend this Release to be a complete and unconditional release of all liability to the greatest extent allowed by law.

10. Participant's Representations
