This Separation Agreement (the “Agreement”) is entered into between:

Recitals:

WHEREAS the parties were lawfully married and have mutually agreed to live separate and apart; AND WHEREAS the parties desire to settle all rights and obligations arising from their marital relationship, including property division, support, and custody matters, amicably and without litigation;

1. Separation:

The parties agree that they have separated and intend to live separate and apart indefinitely. This Agreement is made without admission of fault or wrongdoing by either party.

2. Custody and Parenting Arrangements:

The parties agree on the following arrangements regarding the care of their minor children: the custody, access, decision-making authority, and parenting time shall be as set forth in the attached Schedule A. Both parties agree to act in the best interests of the children at all times.

3. Child Support:

The parties acknowledge and agree that child support shall be paid in accordance with the Alberta Child Support Guidelines. The amount, payment schedule, and method shall be as set forth in the attached Schedule B.

4. Spousal Support:

The parties acknowledge their rights to spousal support under Alberta law. Any agreements or waivers regarding spousal support are detailed in Schedule C attached hereto.

5. Property Division:

The parties have agreed to divide their property as follows: each item, asset, liability, and interest is described and allocated in Schedule D. Both parties warrant that they have made full and frank disclosure of all assets and liabilities.

6. Release of Claims:

Except as otherwise provided in this Agreement, each party releases and discharges the other from any further claims for support, property division, or any other claim arising out of their marriage or separation.

7. Legal Advice:

Each party acknowledges that they have had the opportunity to seek independent legal advice regarding this Agreement and have either done so or voluntarily waived that right.

8. Entire Agreement:

This Agreement contains the entire understanding between the parties concerning the subject matter herein and supersedes all prior agreements, understandings, or representations.

9. Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of the Province of Alberta and the federal laws of Canada applicable therein.

10. Enforcement:

This Agreement is enforceable in a court of law and may be filed as a consent order or relied upon in any legal proceedings as evidence of the parties' intentions.

11. Amendment:

Any amendment or variation to this Agreement must be in writing and signed by both parties.

12. Severability:

If any provision of this Agreement is held to be invalid or unenforceable by a court, the remainder of the Agreement shall remain in full force and effect.
