RECITALS

WHEREAS the Team Leader wishes to engage the Team Members in a collaborative project or activity, and Team Members agree to participate under the terms set forth in this Agreement; AND WHEREAS all parties intend this Agreement to be legally binding and enforceable under the laws of Canada.

1. PURPOSE

This Agreement sets out the terms and conditions under which the Team Leader and Team Members agree to collaborate on the project or activity described herein (the "Project").

2. TERM

This Agreement shall commence on the Effective Date and shall continue until the completion of the Project or until terminated by any party in accordance with this Agreement.

3. ROLES AND RESPONSIBILITIES

3.1 Team Leader Responsibilities: The Team Leader shall oversee the coordination, management, and administration of the Project. They shall communicate milestones, assign tasks, and facilitate collaboration. 3.2 Team Members Responsibilities: Team Members shall diligently perform assigned tasks, attend meetings as required, and contribute their skills and efforts to the successful completion of the Project.

4. COMPENSATION

Any compensation, profit sharing, or reimbursement of expenses shall be agreed upon by the parties in writing prior to or during the Project. Absent any written agreement, no party shall be entitled to compensation.

5. CONFIDENTIALITY

All parties agree to keep confidential any proprietary, sensitive, or non-public information disclosed during the term of this Agreement. Confidential information shall not be disclosed to any third party without prior written consent of the disclosing party, except as required by law.

6. INTELLECTUAL PROPERTY

All intellectual property created or developed during the Project shall be owned jointly by the parties unless otherwise agreed in writing. Parties may use the intellectual property consistent with the purpose of the Project and subject to confidentiality obligations.

7. TERMINATION

Any party may terminate this Agreement upon providing written notice to the other parties. Termination shall not affect obligations or liabilities incurred prior to termination.

8. LIABILITY AND INDEMNITY

Each party agrees to indemnify and hold harmless the other parties from any claims, damages, losses, or expenses arising from their own negligent acts or omissions in connection with this Agreement.

9. GOVERNING LAW AND JURISDICTION

This Agreement shall be governed by and construed in accordance with the laws of Canada. The parties irrevocably attorn to the exclusive jurisdiction of the courts of the appropriate province or territory of Canada for any disputes arising under this Agreement.

10. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, whether written or oral.

11. AMENDMENTS

Any amendments or modifications to this Agreement must be made in writing and signed by all parties.

12. SEVERABILITY

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

13. NOTICES

All notices and other communications required or permitted under this Agreement shall be in writing and delivered by hand, registered mail, or email to the addresses provided by the parties.
