**Clause 1 – Authorization to Travel**

**Clause 3 – Medical Treatment Authorization**

In the event of emergency medical treatment required during travel, the undersigned authorizes the accompanying adult(s) or appropriate authorities to consent to necessary medical care for the minor child, including hospitalization,

surgical procedures, or medication administration.

**Clause 4 – Liability and Indemnification**

The undersigned releases and holds harmless any accompanying adult(s), travel agents, airlines, and other entities involved in the travel from any and all liability arising from the child’s travel, except where caused by gross negligence or willful misconduct.

**Clause 5 – Documentation**

The undersigned confirms that all necessary travel documents for the minor child, including passport and visas if applicable, will be in possession of the child or accompanying adult(s) for the duration of the travel.

**Clause 6 – Governing Law and Jurisdiction**

This Travel Consent Letter shall be governed by and construed in accordance with the laws of Canada and the applicable province or territory. Any disputes arising from this consent shall be subject to the exclusive jurisdiction of the courts therein.

**Clause 7 – Effective Period**

This consent is valid only for the duration of the specified travel dates and destinations unless revoked in writing by the undersigned parent/guardian prior to travel.

**Clause 8 – Signatures and Verification**
