The Vendor has full authority to enter into this agreement and that there are no outstanding claims or encumbrances that would affect the delivery or payment hereunder.

Confidentiality:

The Vendor agrees to keep confidential any non-public information received from the Purchaser and to use such information solely for the purposes of fulfilling this agreement. This obligation shall survive the termination or completion of this Vendor Form.

Limitation of Liability:

Except for liability arising from gross negligence or willful misconduct, the Vendor's total liability under or in connection with this agreement, whether in contract, tort, or otherwise, shall not exceed the total amount paid by the Purchaser for the goods or services supplied.

Termination:

This Vendor Form may be terminated by either party upon written notice if the other party materially breaches any term herein and fails to cure such breach within a reasonable period. Termination shall not affect any rights or obligations accrued prior to termination.

Governing Law and Jurisdiction:

This Vendor Form shall be governed by and construed in accordance with the laws of Canada and the applicable province or territory. The parties consent to the exclusive jurisdiction of the courts located in such province or territory for any disputes arising out of or relating to this agreement.

Entire Agreement:

This Vendor Form constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, understandings, negotiations, and discussions, whether oral or written. Any modifications must be in writing and signed by both parties.
